Demo has been performed to a great extent at the interior courtyard, but some demolition is still needed at the south end. This work will more than likely take a little longer as it will involve leaving some construction while

removing other structural construction.

Sweating in these areas to remain is an issue than will more than likely need to be monitored more closely. At the very least, an extended time for installing new material, once the contractor starts installation, will be needed and moisture measurements will need to be taken of materials to remain. A minimum 30 days drying time is recommended once

conditioning is operational before applying paints, flooring materials,

etc.

On site at Thomas Edwards, workers are pumping water from the current excavation. The majority of demolition has occurred here. The temporary awning at the rear of the site appears to be in good order as

I did not see any leaks after the day's rain.




Figure 2 – Temporary construction @ West Hall looking south




Figure 15 – Existing Wall Construction @ West Hall




Figure 16 – Temporary Shoring at west building/hall to remain




Figure 17 – Opening to remain




Figure 18 – Entry lobby (ceiling to remain [wall on left to be restructured])
